ADDENDUM TO DELISTING DATE ANNOUNCEMENT

1. INTRODUCTION

- 1.1. The Board of Directors (the "**Board**" or the "**Directors**") of LHN Logistics Limited (the "**Company**") wishes to refer shareholders of the Company (the "**Shareholders**") to the following announcements:
 - (a) the formal offer announcement (the "Formal Offer Announcement") issued on 2 August 2023 at 11.17 pm by RHT Capital Pte. Ltd. ("RHTC"), for and on behalf of Milkyway International Chemical Supply Chain Pte. Ltd. (the "Offeror"), stating, *inter alia*, that subject to the terms and conditions of the Offer to be set out in the formal offer document issued by RHTC, for and on behalf of the Offeror, the Offeror will make a voluntary conditional general offer (the "Offer") to acquire all the issued and paid-up ordinary shares (the "Shares") in the capital of the Company, in accordance with Section 139 of the Securities and Futures Act 2001 of Singapore, and Rule 15 of the Singapore Code on Take-overs and Mergers (the "Code");
 - (b) the responses to the Formal Offer Announcement issued on 2 August 2023 by the Board of the Company ("**Responses to the Formal Offer Announcement**");
 - (c) the addendum to the Responses to Formal Offer Announcement issued on 3 August 2023;
 - (d) the offer document dated 16 August 2023 issued by RHTC for and on behalf of the Offeror (the "**Offer Document**");
 - (e) the announcement dated 21 August 2023 made by RHTC for and on behalf of the Offeror in relation to, *inter alia*, the level of acceptances of the Offer which has been received by the Offeror, the Offer being declared unconditional in all respects, the extension of the closing date of the Offer from 5.30 p.m. (Singapore time) on 13 September 2023 to 5.30 p.m. (Singapore time) on 27 September 2023 and the Offeror's rights of compulsory acquisition ("Unconditional Announcement");
 - (f) the announcement dated 22 August 2023 issued by the Company in relation to, *inter alia*, the loss of public float as required under Rule 723 of the Catalist Rules;
 - (g) the offeree circular dated 30 August 2023 issued by the Company in relation to the Offer (the "**Offeree Circular**");

- (h) the announcement dated 21 September 2023 made by RHTC for and on behalf of the Offeror in relation to the despatch of documents relating to the compulsory acquisition and the right of dissenting shareholders under Section 215 of the Companies Act 1967 of Singapore (the "Despatch of CA Documents Announcement");
- the close of offer announcement dated 27 September 2023 made by RHTC for and on behalf of the Offeror in relation to the close of the Offer ("Close of Offer Announcement");
- (j) the announcement dated 27 September 2023 made by the Company in relation to the close of the Offer and the request for suspension of trading;
- (k) the announcement dated 12 October 2023 made by the Company in relation to, *inter alia*, the Singapore Exchange Securities Trading Limited ("SGX-ST") having no objection to the proposed delisting of the Company from the Official List of the Catalist board of the SGX-ST;
- the announcement dated 27 October 2023 made by the Company in relation to the delisting date of the Company following the completion of compulsory acquisition ("First Delisting Date Announcement"); and
- (m) the announcement dated 30 October 2023 made by the Company stating that the Company will be delisted on 1 November 2023 ("Second Delisting Date Announcement").

- 1.3. Unless otherwise defined, all capitalised terms used herein shall have the meanings ascribed to them in the Offeree Circular.

2. AMENDMENT TO THE FIRST DELISTING DATE ANNOUNCEMENT

- 2.1. As stated in the Despatch of CA Documents Announcement and the First Delisting Date Announcement, the Offeror had on 21 September 2023 despatched the relevant notices to the Dissenting Shareholders in respect of the exercise of its right of compulsory acquisition of the shares of the Company pursuant to Section 215(1) of the Companies Act 1967 of Singapore (the "Compulsory Acquisition").
- 2.2. Due to an administrative delay in the transfer of funds for the Compulsory Acquisition, such funds are expected to be transferred by the end of today, 30 October 2023. Accordingly, the Compulsory Acquisition is therefore expected to be completed on or around 31 October 2023.
- 2.3. Accordingly, per the Second Delisting Date Announcement, the Board wishes to announce that the First Delisting Date Announcement is amended such that the Company will be delisted from the Official List of the Catalist board of the SGX-ST with effect from 9.00 a.m. (Singapore time) on 1 November 2023 following the completion of the Compulsory Acquisition.
